- 1. 2010 re-cap: Improvements in the neighborhood included starting the Kiosk project, budget is balanced, website updates, HOA bylaws up to date (new version posted/linked from www.holidayneighborhood.com), Eco Pass program successful (with 339 house holds we issued >450 individual passes), reserve study was done and recommendations put into action.
- 2. 2011 projects: Build kiosk in the park to post messages for the neighborhood, continue Eco pass program. Continue movies in the park (Proto's Pizza participation possible). Installation of additional dog waste garbage bag dispensers around the park and near the Holiday sign.

Several new building efforts around the neighborhood were discussed but only two lots at the west end of Zamia in Holiday Neighborhood proper remain.

3. Review of the budget for 2011:

Previous year ended with a surplus. Questions where taken and answered by the board. No changes proposed.

- 4. Approval of the budget for 2011 The budget was approved with no objections from the audience.
- 5. Election of board members

Two board members (Dave and Tony) are stepping down in 2011. We have two commercial and two residential representatives on the board, plus one at large position. That means that the board has one commercial slot open now plus one residential slot.

Ronnie, Aaron, and Michael are running again for their respective positions on the board.

Commercial candidate Bryan Bowen from Bryan Bowen Architecture announced his candidacy. Residential candidate Claudia Hanson Thiem announced her candidacy.
