#### **Old Business**

1. Kiosk – check cut for city permit. – Ronnie continues checking in on the building progress with Microstructures. Latest state is that the kiosk is built. Next step is for **Tracey** to contact landscaping guys to mark sprinkler system for the dig.

#### **New Business**

- 3. Any 2012 draft budget inclusions? Ronnie to come up with a proposal for additional landscaping (flag stone) around the new kiosk. Use \$1000 for ball park figure.
- 4.
