- 4. Refreshed proposed budget: emailed to Board
- 5. Emailed sub HOA's the dues increase letters
- 6. Requested ballpark pricing from vendors for park committee
- 7. City ended up installing mulch rings at park

Old Business

- Finalizing 2014 Budget Board reviewed the budget and made some final adjustments.-Tracey to look into advice from Reserve study – see next item – to see how we will pay for the repainting of the sign (Capital improvement)
- Reserve Study Dave to look at our reserve study on file and try to form an opinion if we are on track, behind – discuss with Steve and Ronnie and then at the next Board meeting ...
- 3. Water was over budget again in 2013: Community Gardens uses water that the HOA pays for. Board to assess usage and consider billing Community Gardens users for water usage in 2014. Also, **Aaron** to still make a call to the City asking about our water being over budget in 2013– from looking at our latest bill it seems that our budget is set way too low ...
- 4. Sprinkler water still hits the kiosk **Steve** to start talking to the City (this is a city water head doing the spraying) and pull Ronnie into the conversation as/if needed
- 5. Green Spaces 2014 contract pricing approved by the Board
- 6. Irrigation lock bid was previously approved by the Board and Board decided to go go forward with the work.
- 7. Sign rental Aaron tell Andy, our webmaster to include instructions on how to rent the sign on the website.
- 8. Renewal of agreement with the City for the Holiday Park **Aaron** is in contact and negotiating with Boulder City Parks (Jeff) and will share all new information with the rest of the board member (such as the potential installation of a shade structure in the kids playground).
- 9. Board still needs to develop a written policy for what can go on the Holiday sign. Aaron checked and said that there are no existing rules that he could find. Claudia was supposed to look for a boiler plate model for the kind of message board we have and send to the board – this action now needs a new owner (**Ronnie** to decide)

New Business

- 1. HB 1276 Collections Policy: Board approved to move forward with having Orten Cavanagh & HolmesAttorneys to make the update
- 2. Ball park pricing Park: sidewalks, gardens, (irrigation) rough estimates attached Board reviewed a ball-park estimate from Wild Earth Gardens on re-doing the area near the little lending libaray and in light of the \$15K estimate decided to hold off on this work until Board decides how to fund it – also the estimate was deemed high.
- 3. Eco Pass Flier to advertise the hand-out nights for renewal for 2014 Michael to finalize and send to Tracey for inclusion in the annual mailing
- 4. Expertise on the Board; roles, responsibilities, best practices Board decided to have owners for key area of expertise. They will present on their topics to the Board first; on a Friday TBD in December (15 min in-depth) and at the annual meeting,(5 min max highlevel). Areas and owners are as follows
 - a. Reserve Study and other HOA Finances; Treasurer duties Dave
 - b. Landscaping, Maintenance, Tree, Grounds maintenance -Steve
 - c. Kiosk, Library, Park, Holiday Sign (contract with the City etc.) Ronnie
 - d. Eco Pass and Secretary duties on the Board Michael
